RELEASE, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT

In consideration of participating in activities, and for other good and valuable considerations, I hereby agree to release and discharge from liability arising from negligence Marathon Parks and Jay and Judy Punke and owners, directors, officers employees, agents, volunteers, participates, and all other persons or entities acting for them (hereinafter collectively referred to as "releases"), on behalf of myself and my children, parents, heirs, assigns, personal representatives and estate, and also agree as follows:

1. I acknowledge that participating in snowshoeing activities involves known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death, and property damage. Risks include, but are not limited to, broken bones, torn ligaments, or injuries as a result of falls or contact with other participates; conditions resulting from physical activity; and damage to clothing and other property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
2. I expressly accept and resume all the risks inherent in this activity or might have been caused by negligence of the release. My participation I this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that the event conditions are unsafe or I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releases from and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releases or anyone acting on their behalf be required to incur attorney's fee costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
4. I represent that I have adequate insurance to cover any body or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself.
